The group has a huge email distribution list, Casey is updating that to create 2 separate groups, one who will receive monthly email updates, one for people who are actively engaged. Update on performance and trends

- Assessor Data (Laura) (see charts) Increase in referrals, 0 duplicate referrals, no show rate has decreased, 4 referrals in to shelters, shelter numbers continue to rise, increased referrals to Mary's Place.
 - The ending of the eviction moratorium and rental assistance might be a cause, will most likely see even higher rates coming up.
 - Diversion staff have indicated they have increased capacity for families.
- 2. DAP data (Tracy) 25 assessments completed in February (see attachment)
- 3. HC & Priority List Data (Amy & Tracy) 79 families added to list, numbers trending up. EHVs for families need to be tied to case management which is not funded.

Should we reach out to nontraditional family service providers. Is HSS an option? Are ARMs workers or ILS a resource? Tracy and Amy will gather a workgroup to address this issue.

<u>Updates from CES Planners</u> (Tracy)

Committee Task Calendar - (Plug it in the manual and then Google drive) Could potentially be used at monthly meetings to track progress

Transfer Policy - added interagency transfer portion (within an agency) - CES Chat feedback.

Professor Nick Arnosti from the U of MN to attend our ongoing meeting – Tracy He studies wait lists within public housing and mechanisms to provide housing referrals. Comments:

What is the hoped outcome? He could provide recommendations for system efficiencies Tracy will share an email she received about this request

Committee should establish boundaries about guests in the meetings

Tracy will speak with Singles leadership about his attendance

New Youth Housing Voucher - Casey - Available to some youth, including youth headed families

HUD appropriation of new housing vouchers targeted at foster youth to independence (FYI) vouchers, 5 year program without any case management funding, some youth providers have stepped up, each of the 4 providers gets up to 25 vouchers per year. They can serve singles and young families.

Tenzin could you potentially work with the eligibility work support youth team?

What is their definition of experiencing homelessness? HUD definition of 4 categories but includes category of at risk youth which is super broad.
