Charlotte M had suggested that their new employee take on the role, will follow up and report back.

YouthLink person has expressed an interest but we need to clarify their role, from an assessor or facility manager site. Two PPL staff expressed interest from their viewpoint as property management/development.

What slots are open? Person with lived experience. We need a family with lived experience to be involved. Probably half of people involved in YAB are youth with families. It would be nice to have a family who has gone through the CES system if possible.

Laurel L - We at PSP can tap into our advisory committee for feedback and will explore that option.

 Released RFA for new housing funding for youth.

HUD has appropriated new housing vouchers. Each housing authority brings 25 vouchers into their agency, so that is potential 100 housing vouchers for youth with foster experience in Hennepin County. There is the potential to bring in 100 more next year. RFI out to add six providers will provide services. Program expected to be fully implemented by October 1 this year.

Definition of involvement in foster care – Federal definition states any foster care at any age before age 18. In Hennepin County youth with foster care after age of 14 is being emphasized.

 We are moving into next phase of this and have sent out 380 referrals, Metro HRH has reached referral max applications. MPHA submitted @40, have @40 remaining.
 - C. Medical Fragility –Tracy
 There are levels of disability, same approach is used even though needs will vary. Short tool was created to help CES system determine who is medically fragile. Healthcare for the Homeless worked to draft the tool. Susannah national initiative will be discussed at a conference next month.

Questions

Is there consideration or discussion around added barriers around verifying medical fragility? No verification of medical fragility would be needed, it is just asking more specific questions, current assessment may be adjusted. Goal to connect with other entities that can serve people's care needs.

How will this impact other programs like RRH? All types of providers have commented that they are receiving referrals for people with health issues that they cannot address. This might address that concern.

Course of action: Will be sent out to Families and Singles leadership groups, LEAG group for feedback. Bring back feedback to this meeting for discussion. Use tool as part of prioritization process and with partners providing housing services.
